

Information for Religious Studies GCSE, EDUQAS Route A

Exam Structure

The RS exam is divided into three main components:

1. **Component 1: Religious, Philosophical, and Ethical Studies in the Modern World** • Topics include issues of relationships, life and death, good and evil, and human rights.
 - This component is worth 50% of the final grade.
2. **Component 2: Study of Christianity**
 - Focuses on beliefs, teachings, and practices of Christianity.
 - This component is worth 25% of the final grade.
3. **Component 3: Study of Islam**
 - Students will study the beliefs, teachings, and practices of Islam.
 - This component is worth 25% of the final grade.

Revision Ideas

- **Regular Revision:** Encourage your daughter to review her notes regularly and use revision guides.
- **Past Papers:** Practicing past exam papers can help familiarize her with the exam format and question styles.
- **Mind Maps and Flashcards:** These tools can help in summarizing key concepts and making revision more interactive.
- **Group Study:** Studying with peers can provide different perspectives and enhance understanding. **Common Exam Questions**
- **Define Key Terms:** For example, "What is omnipotence?" or "What is stewardship?".
- **Describe Concepts:** Such as "Describe the role of Word and Spirit in creation".
- **Explain Significance:** Questions like "Explain why the concept of the Trinity is important in Christianity".
- **Evaluate Arguments:** For instance, "Evaluate the arguments for and against the existence of God".

Skills Needed

- **Knowledge and Understanding:** Detailed knowledge of the subject material and the ability to explain beliefs and actions.
- **Key Vocabulary and Sources of Authority:** Familiarity with key terms and references to scripture or religious teachings.
- **Impact and Analysis:** Understanding how beliefs influence actions and the ability to break down topics into parts.
- **Argument and Evaluation:** Giving reasons for different viewpoints and weighing up ideas to come to a judgment.

- ASKS YOU TO *DESCRIBE* AN IDEA, EVENT, CEREMONY, BUILDING, BELIEF, TEACHING, VIEW, ATTITUDE ETC.
- DESCRIBE MEANS TO OUTLINE / REPORT / GIVE DETAILS OF
- WRITE AT LEAST FIVE ACCURATE AND DETAILED PIECES OF INFORMATION, INCLUDING SOURCES OF WISDOM AND LOTS OF SPECIALIST LANGUAGE
- NO MORE THAN 5 MINS

ANSWERING GCSE RS EXAM QUESTIONS

PART C (8 MARKS)

- ASKS YOU TO *EXPLAIN* AN IDEA, EVENT, ACTION, CEREMONY, BUILDING, BELIEF, TEACHING, VIEW, ATTITUDE ETC.
- EXPLAIN MEANS TO GIVE REASONS / MAKE CLEAR BY GIVING MORE DETAIL / CLARIFY / GO BEYOND DESCRIPTION BY OFFERING MORE DEPTH
- USE WORDS LIKE 'BECAUSE', 'THIS SHOWS THAT...', 'THIS IS IMPORTANT BECAUSE...'. INCLUDE LOTS OF SPECIALIST LANGUAGE AND SOURCES OF WISDOM
- IN THE THEMES PAPER YOU NEED TO WRITE FROM TWO DIFFERENT RELIGIOUS VIEWPOINTS (DETAILED PARAGRAPH FOR EACH)

PART D (15 MARKS)

- ASKS YOU TO DISCUSS A STATEMENT (ASSESSING ANALYSIS AND EVALUATION SKILLS)
- YOU NEED TO GIVE SUPPORTED ARGUMENTS AND REACH JUDGEMENTS ON HOW CONVINCING THE EVIDENCE IS THAT YOU PRESENT. YOU SHOULD INCLUDE LOTS OF SPECIALIST LANGUAGE AND SOURCES OF WISDOM
- EACH VIEW ON THE STATEMENT THAT YOU GIVE SHOULD BE BACKED BY TWO SETS OF EVIDENCE. YOU SHOULD THEN CHALLENGE THE VIEW, AGAIN USING EVIDENCE. YOU SHOULD AIM TO DO THIS TWICE.
- IF YOU HAVE TIME AT THE END YOU CAN ADD A CONCLUSION IN WHICH YOU SAY WHICH VIEW IS THE MOST CONVINCING USING WORDS FROM THE ORIGINAL STATEMENT. THIS SHOULD BE SUPPORTED WITH EVIDENCE.
- FOR THE LIFE AND DEATH TOPIC YOU MUST GIVE A NON -RELIGIOUS VIEW
